- 1. The Ministry of Health of the Republic of Serbia has received financing from the World Bank toward the cost of the "Serbia Emergency Covid-19 Response Project" and intends to apply part of the proceeds toward payments under the contract for the construction of a new diagnostic building with BSL-3 laboratory at the "Torlak" Institute of Virology, Vaccines and Sera.
- 2. The Project Coordination Unit, on behalf of the Ministry of Health of the Republic of Serbia, now invites sealed Bids from eligible Bidders for the construction of a new diagnostic building with BSL-3 laboratory at the "Torlak" Institute of Virology, Vaccines and Sera, Belgrade, Serbia:

The planned floor structure for the building is GF + 3 and B + GF + 3. The total gross floor area of the whole building is 4,792.02 m2.

The roof will be flat, impassable (it will serve only to accommodate the equipment and devices required for the building's operation). The roof precipitation drainage will be carried out using the Geberit Pluvia drainage system.

There will be sixteen (16) parking spaces for employees in the underground garage inside the building, two of which will be reserved for persons with special needs.

The ground floor will be divided into several functional units positioned along the building's entrances/exits (for employees, patients and for bringing in supplies)

Auxiliary technical rooms will be located on the second floor.

The third floor will be a single-volume manipulative space connected to the other floors by means of stairs and elevators.

On the first floor, a state-of-the art BSL3 laboratory with a containment area of ca. 150m² will be located. It is equipped with complete installations, which enable safe and secure work,

including the ventilation system, air conditioning, negative pressure control, 2 pass-through autoclaves, thermal effluent decontamination system, VHP-passbox, etc. In addition to these, installations for automatic fire extinguishing will be provided.

The construction of the building will be made of reinforced concrete elements cast on site.

All exterior facade walls will be made of 20 and 25 cm thick blocks and 12 cm thick stone wool thermal insulation, over which a ventilated facade made of the Larson ® ACP type composite aluminum panels or similar will be installed. External locks have been planned with a construction of aluminum profiles with enhanced thermal characteristics. The inner partition walls are designed as dry assembly (double plasterboard panels on a metal substructure with thermal stone wool filling, in toilets with waterproof plasterboard panels) and, if necessary, in a system of partition panels for clean rooms, for all laboratories and other rooms with increased hygiene requirements.

The building will have daylight and artificial lighting, water supply and sewerage installations, electrical power installations, telecommunication and signal installations, mechanical installations, fire protection.

Time for the contract completion is 9 months. Margin of preference does not apply.

Bidding will be conducted through international competitive procurement using Request for Bids (RFB) as specified in the World Bank's "Procurement Regulations for IPF Borrowers-Procurement in Investment Projects Financing" *July 2016, Revised November 2017 and August 2018* ("Procurement Regulations"), and is open to all eligible Bidders as defined in the Procurement Regulations.
